19 May, 1980 – Articles of Incorporation filed for a Utah non-profit corporation named Hideaway Valley Property Owners Association, Inc. A Non-Profit Corporation (file # 740755-0140).  
31 March 1984 – Involuntarily Dissolved  
26 June 1984 – Reinstated  
17 January 1991 – Amended Articles of Incorporation  
19 August 2002 – Involuntarily Dissolved

15 August 2006 – Filed Articles of Incorporation for a Utah Non-profit Corporations named Hideaway Valley Property Owners Association, Inc. (file #6298506-0140) - previous corporation had passed the statutory timeframe for reinstatement.
